 of my Executors herein after named & as to the Worldly Estate  
 God has been pleased to bless me with. I dispose of in the  
 following manner viz. — First. I lend unto my beloved wife  
 Judith Robertson my whole Estate both real and personal  
 during the term of her natural life and after her decease to  
 be divided as followeth Viz. — Item I give and bequeath unto  
 my Wifes son Henry Mills one negroe man named Dick to  
 him and his heirs forever. — Item I give and bequeath unto my  
 son Jeffrey Robertson one negroe boy named Jerry to him and  
 his heirs forever. — Item I give and bequeath unto my son Tyra  
 Robertson one negroe girl named Annica. also five pounds to  
 him and his heirs forever. — Item I give and bequeath unto  
 my son Nicholas Robertson one negroe girl named Aylchra  
 to him and his heirs forever. — Item I give and bequeath

and a negro boy named Anthony to him and his  
heirs forever. Item I give and bequeath unto my son David  
Robertson one negro woman named Kate one negro boy  
named Joe and my gun to him and his heirs forever.  
Item I give and bequeath unto my son Mills Robertson one  
Negro man named Ben & one negro girl named Tall. to him  
and his heirs forever. Item I give and bequeath unto my  
daughter Elizabeth Bass One Feather bed & furniture and one  
Man called Fanny to her and her heirs forever. Item I  
give and bequeath unto Sarah Slate one horse called Trimmer  
one Saddle and bridle one Bed & furniture One Chest two Wheel  
One bottom the other Haven also lend unto her one negro  
boy named Stephen during her natural life and at her death  
I Will and bequeath the s<sup>d</sup> negro Stephen unto my Son  
Nicholas Robertson to him and his heirs forever together  
with the s<sup>d</sup> horse if he should survive her. Lastly I do  
nominate and appoint my sons Nicholas & Matthew Robert  
Executors of this my last Will & Testament I also Will that  
my Estate be not appraised and <sup>that</sup> after my Wifes death  
the remainder of my Estate that is not herein Willed

be equally <sup>divided</sup> amongst all my children by my Executors as they  
shall think proper in Witness whereof I have hereunto set  
my hand and affixed my seal this 16<sup>th</sup> day of December Anno.
